Athena Cuts Rooting Compound is formulated with an essential hormone that promotes rapid root generation and growth. Athena Cuts Rooting Compound may be used on any type of cutting, including woody, herbaceous, and flowering ornamental species, vegetables, fruit trees, and small fruits.

TAKING CUTTINGS:

Take cuttings only from new growth on healthy plants. Trim cuttings to 2-8 inch pieces. Make cuts at a 45-degree angle. Do not dip cuttings into container. Do not pour used gel back into the container. Immediately dip into Athena Cuts Rooting Compound, or immerse in water until ready to be dipped. The cuttings can also be re-cut prior to dipping. Spray cuttings frequently, and use a humidity dome to prevent excessive wilting.

APPLICATION INSTRUCTIONS:

First empty a small amount of Athena Cuts Rooting Compound into a separate container. Do not dip plants directly into the bottle. Dip the cut end of the stem into Athena Cuts Rooting Compound to desired depth. After Athena Cuts Rooting Compound has been applied, place cuttings into the rooting medium. Depending on the species, rooting will take place in days, weeks, or months under optimal environments. Transplanting may be performed once the cuttings have rooted.
