EFFICACY

Athena[®] IPM is an effective treatment against many soft-bodied insects such as white fly, spider mites, and aphids. Will treat adults, nymphs, larvae and eggs. Kills on contact. Also effective in treating common fungal infections such as powdery mildew.

APPLICATION INSTRUCTIONS

IPM is for household use on non-food crops.

Treatment Strength: Mix 90-120 mL Athena[®] IPM per gallon (238-317 mL per 10 L) of water. Spray with lights off or in early morning sun. Start with a lower dose then increase if problem persists. At least 3 applications spaced 3 days apart are required to treat most pests. Spray tops and underside of all leaves and stems to completely saturate the plant.

Prevention Strength: Mix 50-60 mL Athena[®] IPM per gallon (132-159 mL per 10 L) of water. Spray with lights off or in early morning sun. Apply 2-3 times per week for maximum results. Spray tops and underside of all leaves and stems to completely saturate the plant.

Root Drench: Mix 5-10 mL Athena[®] IPM per gallon (13-26 mL per 10 L) of water. Saturate media completely until slight runoff. Compatible with all fertilizers and additives.

Stack
A foliar plant nutrient that encourages strong growth and flowering.

STORAGE & DISPOSAL
