**SECTION 4: FIRST AID MEASURES**

**FOLLOWING INHALATION:**

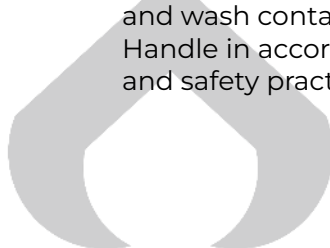
