- Typical use rates are 0.5oz 2.0/gallon. 1oz gallon (30mls/gal) is recommended for routine slime and
- Inject into system using a common medicator
- Uncap the system at its furthest point and check for effervescence to ensure solution has complete
- Activate all emitters.
- hold the solution in the system for 12-24 hours
- · When cleaning is complete, thoroughly flush entire system with potable water
- · It is recommended to use an EPA registered sanitizer disinfectant after cleaning is complete.
